## Application fee

This application form will generate an application fee of R2 750.00 (excl VAT) per product group plus an initial activation fee as detailed below. Once Eco-Choice Ecolabelling has received the completed application, an official invoice will be issued. No application shall be considered before payment of the relevant application fee

## Activation Fee

1. All first applications for **new products** require an **activation fee** of R9 500.00 (excl VAT), irrespective of the number of products for which the application is submitted.
2. All first applications for **existing products** require an **activation fee** equal to 1.5% of nett sales turnover (excl VAT) of the previous year's sales with a minimum initial fee of R17 500.00 (excl VAT), irrespective of the number of products for which the application is submitted.

## Annual Licence Fee

1. All Licence holders of licenced products shall pay an annual licence fee equal to 1.0% of net sales turnover (excl VAT), quarterly in arrears from the date of registration. There is a minimum annual licence payment of R12 500.00, and where the quarterly licence fees do not equal these targets in any year, the licence holder is required to pay the shortfall before a licence is renewed.

## Undertaking by the applicant

We have studied the provisions of the "Regulations for Eco-Choice Ecolabelling of Products". If our application for an Eco-Choice Ecolabelling Licence is granted, we undertake to follow these regulations and the Ecolabelling criteria and other regulations of which we are notified by the Ecolabelling Administrators.

We undertake to follow the rules and standards of the Eco-Choice Ecolabelling Programme and commit to the following conditions of participation:

- o to conform to the relevant official requirements concerning the internal and external environment in all handling of the product during manufacture, distribution or sale,
- o to use the Eco-Choice Africa Ecolabel only on products which conform in all respects to the provisions of the relevant Ecolabelling criteria,
- o not to use the Eco-Choice Africa Ecolabel on products other than those covered by the Ecolabelling licence,
- o to follow the rules for the use of the Eco-Choice Africa Ecolabel according to paragraph 12 in the "Regulations for Eco-Choice Ecolabelling of products",
- o to give reliable information on the implications of Ecolabelling in the marketing of Ecolabelled products in advertisements and other publicity material associated with the products that have been licenced,
- o to pay the required fees to the Eco-Choice Africa Administrators and other costs related to our application and inspection and testing of ecolabelled products that are specified in the relevant Ecolabelling criteria and other regulations,
- o to indemnify the Eco-Choice Africa Ecolabel and its Administrators in the event of claims for damages or other economic disbursements which Eco-Choice Ecolabelling has incurred as a result of damage caused by a product manufactured and/or sold by the licensee, which also includes faults and shortcomings of the product itself.



We/I understand that the Agreement giving the licensee a right to use and refer to the Eco-Choice Ecolabel comes into force when the Eco-Choice Administrator has issued the licence and it ends on withdrawal or cancellation of the licence by Eco-Choice Ecolabel.
